



## 2025 Breeding Contract Bontfire XX06 Preferent

This 2025 contract is in effect for one breeding to the KWPN Registered and Barock Pinto Studbook Approved Stallion, **Bontfire XX06 Preferent** to the mare

\_\_\_\_\_. This agreement is valid only for the 2025 breeding season. The Mare owner and Windhorse Mountain Equine agree to the following terms and conditions:

- 1) **BREEDING:** Semen shipped is to be used for only the mare identified in this agreement. This agreement cannot be transferred or sold by the mare owner. There shall be no right of return to the stallion if the mare is sold or otherwise changes ownership. The breeding right is sold with a 2-year term on a live foal guarantee which includes the 2025 and 2026 breeding seasons.
- 2) **BREEDING FEE AND BOOKING FEE:** The Breeding Fee for **Bontfire XX06 Preferent** is \$1800.00 USD This price includes a non-refundable booking fee of \$500.00 USD payable with this Agreement, which reserves for 2025 a breeding for the Mare. Mare owner agrees to pay the balance and any other fees due before shipment of semen shall be made.
- 3) **MULTIPLE MARE BREEDING FEE DISCOUNT:** A multiple mare discount of 100.00 per mare will be applied on each mare in multiples of 2 or more.
- 4) **COLLECTION FEES:** Shipped Semen within the U.S. - The mare owner will be responsible for all costs involved in collection. Orders canceled after the stallion has been collected will be billed in full. The shipping and collection fee is \$400.00 USD for weekday delivery and \$450.00 USD for Saturday delivery, which is due on or before the date of collection. Semen will not be shipped if the collection fee is not paid. The collection fee includes semen collection, evaluation, packaging for shipment and shipping fees. The collection fee quoted is PER SHIPMENT PER MARE shipped to. A single collection which is processed for multiple mares will be billed at the stated rate for each mare. Same day pick up is available if you would like to pick semen up at the farm - \$300.00 USD.
- 5) **INTERNATIONAL SHIPMENTS:** For shipments to Canada, Netherlands, Italy or Mexico, please call for collection fees.
- 6) **BREEDING SEASON:** The 2025 breeding season for **Bontfire XX06 Preferent** is from March 1 to July 31, 2024.
- 7) **FRESH OR COOLED SEMEN WILL BE AVAILABLE IN THE ORDER CONTRACTS HAVE BEEN RECEIVED** Advance booking will place your mare at the top of the list for shipped semen. All other semen requests will be placed in the order of when the contract was signed, and booking/breeding fee was paid.
- 8) **COOLED SEMEN ORDERS:** For semen to be collected and shipped for timely arrival, semen must be ordered **the day before** the intended insemination and **before 12:00 PM** Pacific Standard Time for shipment. **Bontfire XX06 Preferent** is collected Monday, Wednesday and Friday (except holidays and the day before a holiday) with delivery the following day. No Same Day Shipments.
- 9) **REQUESTS FOR SEMEN:** To request semen contact Sharon Bechler at 559 642-8004. A message can be left on the telephone. Messages are checked several times a day. Advance requests can also be made by call or text. Confirmation of the order of semen will be given via call or text. Please do not call between 10:00 PM and 6:00 AM Pacific Standard Time. Windhorse Mountain Equine must receive reasonable notice of need for collection and shipment date. The mare owner is advised to notify Windhorse Mountain Equine at the start of the mare's cycle and again on the date requested to collect and ship semen.
- 10) **LOSS OF SEMEN:** Windhorse Mountain Equine assumes no responsibility for the loss of semen or loss of semen viability caused by the carrier (FedEx). There will be no shipment on Saturdays, Sundays, holidays, or the day before a holiday.

- 11) **LIVE FOAL GAURANTEE:** Should the Mare fail to conceive, abort, die or not produce a "Live Foal" (Live Foal shall be defined as a foal that stands and nurses without assistance for a of period of 24 hours from the time of birth) the Mare Owner or Leaser (person paying the stud fee) shall have the right to rebreed or substitute a mare to rebreed if the mare in this contract dies, with documentation of the cause of failed breeding/live foal and the approval of Windhorse Mountain Equine, during the 2025 breeding season or the 2026 breeding season only. Mare Owner shall notify Windhorse Mountain Equine within sixty days of the last day of Breeding Season if the Mare did not conceive, to be eligible for a rebreed. Mare Owner shall also notify Windhorse Mountain Equine within thirty days of the Mare's abortion, should the Mare abort. If the Mare does not produce a "Live Foal", then the Mare Owner shall provide Windhorse Mountain Equine with a veterinarian's certificate stating the time, date and cause of death and the time and date of birth, within seven calendar days of the event. If the mare dies, Mare Owner shall provide Windhorse Mountain Equine with a veterinarian's certificate of death within seven calendar days of the event. If Mare does not become pregnant within two breeding seasons, Mare Owner no longer has the right to rebreed the Mare to this stallion and forfeits all fees paid to Windhorse Mountain Equine.
- 12) **RETURN SERVICE PRIVILEGE:** The return service privilege in this contract is non-transferable and non-assignable. Should the Mare be sold or otherwise disposed of prior to the birth of the foal, the return service privilege shall be void.
- 13) **REFUND:** Mare owner shall not be entitled to a refund of fees paid except if the stallion should die or become unfit for service prior to serving the mare in the present 2025 breeding season. Once the mare has been serviced, there will be no refunds of any kind. Should the stallion die after the mare has been serviced, the return service privilege becomes null and void.
- 14) **MARES' HEALTH:** Stallion service will be provided only to healthy mares in sound breeding condition, as determined by a licensed veterinarian. A breeding soundness exam is strongly recommended prior to shipping semen. Mares should be bred immediately upon shipment under the guidance and supervision of a licensed veterinarian. If the Mare has been open, Windhorse Mountain Equine may require the submission of a recent uterine culture certificate. If the Mare fails to become pregnant after two cycles, Windhorse Mountain Equine may require the Mare Owner to obtain a current reproductive exam and uterine culture prior to any further shipments. Windhorse Mountain Equine cannot be held responsible in any way for any illness or injury to a mare or to any other horse due to breeding to **Bontfire XX06 Preferent**, nor for a mare's failure to conceive.
- 15) **CONTRACT:** This Breeding Contract must be in writing, and the parties agree that a printable email version of the contract shall qualify as "in writing". This contract shall be governed by the laws of the state of California and shall be binding upon the parties hereto and their personal representatives.
